This dissertation criticizes the naive adoption of the OECD Principles of CCG by the Pakistani government and provides empirical grounds for discussions on the improvement of the current CCG by proposing an adequate <i>ex post</i> evaluation and governance mechanism given the specificities of Pakistani corporate finance context. The candidate successfully demonstrates a distinct contribution to a body of knowledge through his original investigation and testing of his hypotheses on (i) the Pakistani firm-specific factors, (ii) the impact of ownership patterns and (iii) the impact of internal attributes of corporate governance for the selection of capital structure. Summary of Dissertation Screening Results	The candidate demonstrates his mastery of a body of knowledge, including previous works particularly on the theories of agency problem in corporate governance, and keen understanding of econometric approaches to analysing the relationship between corporate ownership and capital structure. The screening committee unanimously concurs though his oral defense that the candidate meets the key requirements for a doctorate degree at APU (Clause 2 of Procedures for the Conferral of Doctoral Degree in the Graduate School of Asia Pacific Studies).
Summary of Examination Results or confirmation of Academic Skills	The screening committee members unanimously recommended that the candidate be awarded a PhD. Through the oral defense, the candidate successfully demonstrated his competence in research processes including econometric techniques.
