	investment in rural tourism infrastructure in recent years can't be sustainable without incorporation of the new economic environment to the local and traditional one. Monitoring system and tourism statistic is one of the first and highest priorities and relies on human resource development. DMOs are critical and need to be established and supported. It also concludes that CBT in Tajikistan rural context should be defined and designed systematically though public and private collaborations in order to sustain rural development.
