Summary of Dissertation Screening Results	<p>The dissertation distinguishes itself as a novel and innovative contribution to existing literature in the AI field in several ways. First the research of emotional artificial intelligence (EAI) employs a mixed methods approach combining qualitative as well as quantitative research.</p> <p>In terms of its qualitative work, the candidate drew extensively from data collection derived from his role as a my research assistant on a grant entitled, <i>Emotional AI:Cross-Cultural Lessons on how to live ethically and well with Emotional AI technologies in Smart City Design</i>. During this period, the candidate relied on data collection from mapping the ecology of emotional AI stakeholders in Japan, desktop analysis, Bayesian Analysis, Sentiment Analysis, numerous interviews with various EAI stakeholders in Japan, design workshops held with various segments of the population as well as local and national surveys.</p> <p>The dissertation deserves recognition as it provides novel insights into the impact of AI on society, specifically, the nascent field of affective computing. The fact that the candidate has already published much of his findings in some of the leading Q1 internationally recognized peer reviewed is proof of his level of achievement as evidenced in this dissertation.</p> <p>Importantly, the candidate's research is of vital importance to academic research but also society at large since AI technologies are dramatically and rapidly reshaping how we work and live.</p> <p>In order to verify the claims made in this dissertation, a viva voce was held on Jan. 16th, 2023 at Ritsumeikan Asia Pacific University. A unanimous decision was reached by the examiners in which they decided the candidate was deserving of being awarded the degree of Doctorate of Philosophy as well as being nominated for a special award for his outstanding work.</p>
